

# Guidelines for Authors

## *p-Adic Numbers, Ultrametric Analysis and Applications*

*p-Adic Numbers, Ultrametric Analysis and Applications* is an international interdisciplinary journal which publishes review articles, research articles and short communications related to in various areas of pure and applied mathematics related to  $p$ -adic, adelic and ultrametric methods, including: mathematical physics, quantum theory, string theory, cosmology, nanoscience, life sciences; mathematical analysis, number theory, algebraic geometry, non-Archimedean and non-commutative geometry, theory of finite fields and rings, representation theory, functional analysis and graph theory; classical and quantum information, computer science, cryptography, image analysis, cognitive models, neural networks and bioinformatics; complex systems, dynamical systems, stochastic processes, hierarchy structures, modeling, control theory, economics and sociology; mesoscopic and nano systems, disordered and chaotic systems, spin glasses, macromolecules, molecular dynamics, biopolymers, genomics and biology; and other related fields.

Articles are published only in English. Manuscripts should be submitted by e-mail to the editorial board at the address [p-adics@mi.ras.ru](mailto:p-adics@mi.ras.ru).

By submitting a manuscript to *p-Adic Numbers, Ultrametric Analysis and Applications*, the authors guarantee that it has not been published elsewhere or considered for publication elsewhere. All submitted manuscripts are peer reviewed and manuscripts of high quality are accepted for publication. The accepted manuscripts are edited and sent to authors for corrections before publication. Together with a manuscript, authors should submit completed, signed and scanned copy of the [Copyright Transfer Agreement](#).

The submitted paper should normally be prepared in one of the standard  $\LaTeX$  formats. The manuscript should contain the title, complete list of all authors, complete affiliation of each author, e-mail address of the corresponding author, abstract, keywords, structured text, and references.

To avoid possible errors, which can be made by the journal software during compilation of articles, authors should not abbreviate  $\LaTeX$  commands, because they can interfere with the same abbreviations of the other authors of different meaning.

To speed up preparation of the article for publication, submitted manuscripts should be prepared taking into account the following instructions:

- Equations are numbered consecutively throughout the manuscript or throughout each section (double numbering). Theorems, lemmas, etc., are numbered similarly.
- Footnotes are also numbered consecutively using Arabic numbers.
- Figures must be in EPS format and with Courier font.
- Acknowledgements should be placed before the list of references.
