

# Guidelines for Authors of *Radioelectronics and Communications Systems*

*Radioelectronics and Communications Systems* publishes manuscripts free of charge. Content of manuscripts submitted to the editorial board should correspond to the profile and scientific and technical level of the journal. The length of manuscripts should not exceed (including figures) 4 typewritten pages for the letters to the editor; 20 pages for reviews; and 12 pages for original articles, which in the latter case corresponds to 9 pages of A4 format, typeset using a computer with single line spacing and a font size of 12 pt. The number of figures (including parts a, b, ...) should not exceed the number of pages. The manuscript should be carefully edited, accompanied by the statement that “the work has not been published previously,” and signed. The submission should include:

- A manuscript in an editable format (\*.doc, \*.docx, \*.wp, \*.tex) and PDF format, signed by all the authors;
- A scanned copy of the [copyright transfer agreement](#) completed and signed by all the authors;
- Information about the authors (full names, academic degrees and titles, affiliations and positions, postal addresses, e-mail, phone numbers, [ID ORCID](#));
- Keywords;
- A list of abbreviations;
- Graphics files to the manuscript.

The manuscript should be submitted by e-mail or through the *Radioelectronics and Communications Systems* website.

Programs that are used by default:

- MS Word 2003 + MathType
- Adobe Photoshop
- Corel Draw 13

Files created in other programs will undergo additional conversion. In this case, it is recommended to submit a PDF version of the manuscript file in order to minimize conversion errors.

The first page of the manuscript, except for the text, should contain the names and initials of the authors, a title, and an abstract (10–12 lines). The content of the manuscript should be stated concisely and clearly to readers, without many mathematical calculations (if necessary, proofs of complex formulas can be given in the appendix). The statement of the problem should be given at the beginning of the manuscript, indicating its relevance and goals, and the practical importance of the theoretical results should be summarized at the end.

Figures are presented both in the text and separately (file formats: bitmap figures should be black-and-white, with a resolution of 300 dpi; vector images should be presented both in original form and in WMF format) in two versions: without inscriptions and symbols and with inscriptions. Dimensions of characters in illustrations should be selected such that in scaling down to the journal format they would be 10 pt (3.75 mm) in size. The width of formulas and tables should not exceed the width of the journal page. The figure captions should contain only the number (Fig. ...) and the corresponding information should be given in the text.

Physical quantities and variables are typed in italics. Symbols of operators and math functions are given in Roman type. In decimals, the integer part is separated by a period rather than a comma. Signs of hyphen (-), en dash or “minus” (–), and em dash (—) are different in length. Only those formulas referred to in the text are numbered.

The list of references must comply with order of the references in the text and contain the titles (in-

cluding the titles of journal articles) of published sources available to readers. References to unpublished works, dissertations, local publications, or conferences are not allowed. It is advisable to prepare the list of references and the entire manuscript similarly to articles published in the journal.

Articles sent to the authors for revision (after peer review) should be resubmitted to the editorial board within three months. On disagreement with a reviewer, authors must present a reasoned response to the editorial board, the decision of which is final.

Notes for proofreading (galley proof) should be sent to the editorial board within a month.
