

# Guidelines for Preparing and Submitting Manuscripts to *Differential Equations*

*Please note that the journal will consider submissions in Russian language only*

Manuscripts submitted to *Differential Equations* should meet the following requirements.

1. A manuscript should be thoroughly copyedited prior to submission. The authors should describe their findings in the form of clear statements (propositions, theorems, etc.) with their rigorous mathematical proofs.

By submitting a manuscript to the journal, the authors guarantee that it has not been published earlier (in original or in translation) and is not considered for publication in other journals.

The electronic version of a manuscript (TeX and PDF files) prepared using a LaTeX word processor should be sent to the editor at [liline@cs.msu.su](mailto:liline@cs.msu.su), and two hard copies to the following address: Editorial Board of *Differentsial'nye Uravneniya*, Faculty of Computational Mathematics and Cybernetics, Moscow State University, str. 2, komn. 733b, Moscow, 119992, Russia.

2. All authors should include information about themselves: name and surname, date of birth, affiliations, job title, academic title, work and home addresses, work and home phone numbers with city codes, e-mail addresses, and a list of scientific interests.

3. The manuscript should begin with a title, authors' names, and an abstract. The abstract should be at most ten lines in length and describe the main results. It should not contain literature references, cumbersome formulas, or text duplicated from the Introduction.

4. The length of a manuscript should not be greater than 20 journal pages. The length of a short communication should be at most five journal pages. The manuscript should not contain more than five figures (including figure panes with separate captions). The width of a figure should not be greater than 16 cm, and the height should not be greater than 10 cm. Figures should be black and white bitmap images without halftones. The resolution should be 300 dpi.

5. Numbered formulas should be on separate lines with the number near the right margin. Only those formulas that are referred to in the text should be numbered. Ratios and fractions in a line with text and complex fractions should be typeset using a slash or negative exponents.

Statements (theorems, propositions, lemmas, and corollaries) should be typeset in italic (*textit*).

Mathematical symbols  $\lim$ ,  $\sup$ ,  $\ln$ ,  $\sin$ ,  $\operatorname{Re}$ ,  $\operatorname{Im}$ , etc., and 0 (zero) are typeset using a regular font. An exponential function with a composite argument should be typeset as  $\exp(\dots)$ .

6. References should be numbered in the order they appear in the text. In references to journal articles, it is necessary to indicate the journal title, year, volume, issue number, and pages.

In references to monographs, specific page numbers should be indicated (for instance, [1, p. 30]). References to unpublished work, except for dissertations, are not allowed. Every number should correspond to one reference, and no reference should be duplicated.

7. The manuscript should be signed by all authors. The authors should indicate an appropriate journal section (ordinary differential equations, equations with partial derivatives, integral equations, control theory, numerical methods, finite difference equations, or short communications).

8. Return of a manuscript to the authors for revisions does not mean that it has been accepted for publication. A revised manuscript should be resubmitted to the editorial board together with replies to all reviewer comments. The date received is considered to be the date when the final version of the manuscript has been received by the editorial board.

The final version of a manuscript is considered original, and alterations in proofs are not allowed.

The editorial board reserves the right, without explanation, to reject a manuscript if a substantial portion of it does not match the scope of the journal.

9. Upon acceptance of a manuscript for publication, the authors should fill out, sign, and send in two copies of the copyright transfer agreement to the following address: *Differentsial'nye Uravneniya*, Faculty of Computational Mathematics and Cybernetics, Moscow State University, Leninskie Gory, Moscow, Russia 119991.

Manuscripts that ignore the rules described in these guidelines are rejected without consideration.
